

## Fairland Town Council Minutes July 05, 2022

### Present

Council members present, Jeremy Creech, Rick Daily, and John Merlau.

### Call to order

Meeting called to order at 6:00 PM by Board President, Jeremy Creech.

### Routine Business

#### Approval of Minutes and Claims

- A. Motion to approve the minutes from by Rick Daily, seconded by Jeremy Creech. Motion carried, 2-0.
- B. Treasurer presented claims for the month of June. Rick Daily made motion to approve, seconded by Jeremy Creech. Motion carried, 2-0.
- C. Treasurer presented current balance.
  - a. Jeremy Creech inquired the status of the SBOA Audit – per the auditor assigned to the Town’s records, the audit should conclude in early August.
- D. Town Maintenance:
  - a. Pickleball Court Update – Robbie Stonebreaker/Mike Bowman
    1. After discussion regarding locking and reserving the pickleball courts, it was decided that the pickleball courts would be kept unlocked for community usage. Reservations of the pickleball court will be kept by Shea Fink.
  - b. A “RESERVED” sign will be ordered from Begley’s for the Pickleball Court as well as the Shelter House – this will be paid from Town Maintenance.
  - c. The tile damage caused by Waste Management was discussed.
  - d. Robbie has located on “bad” sidewalk that needs repaired – repairs will be made.
  - e. Four Pole Lights for the park/parking lot/pickleball court to be ordered and installed.

### Old Business

- a. Town Hall Painting Update – Robbie MacDonald has completed his repair work, and the painters will begin in August.
- b. Town Marshall Presentation/Update – new cost information and Indiana Code was shared regarding the addition of a Town Marshall.

### New Business

- a. Robbie Stonebreaker presented the Park Dedication Sign for approval – 5x10 = \$765.00. Rick Daily made motion to approve cost up to \$800, Jeremy Creech seconded the motion. Motion carried 2-0

- b. Stop sign at Edgerton and Burnside has been repaired.
- c. Larkey Insurance provided an updated Town Liability & Motorized Vehicle Policy and Rates to the Town Council Members.
- d. IBEAMS at the Park are a Safety Concern – two options for remedy were discussed and Mike Bowman will work on an estimate and email Jeremy Creech. This work is to be paid from the Maintenance Account.
